Clarification

No recommendation or decision has been made to approve/disapprove the nomination for a plan amendment to the Comprehensive Plan (or future rezoning) regarding Rose Hill Plaza.

Correct Land-Use Language

The Combined Property nomination/application is to <u>amend the Comprehensive Plan</u>; it is not a "rezoning" application. Rezoning comes *after* the Comprehensive Plan is amended and the application is accepted as a "Work Project". Nonetheless, rezoning is required in order to fulfill the plans of Combined Property to add residential units. (Yes, it's very confusing, so don't worry if you don't get the terms exactly right. We are all learning!)

'Given COVID and the recovery from the recent fire, we are focused on ensuring that the

shopping center and our tenants are able to recover as soon as possible. Our focus on these efforts, and, frankly, the feedback from both Staff and the Community, made us realize that continuing to pursue the SSPA at this time does not make sense,' the representative said in the letter.
